GENERAL

Reactive Form Release Citrus is a citrus-scented film forming treatment that prevents the bonding of fresh concrete mix to forms, tools, and equipment. Composed of non-staining natural oils, Reactive Form Release Citrus reacts with excess lime on the surface of the concrete to give a quick, clean stripping from any form work. Max VOC 150 g/L

RECOMMENDED USES

Reactive Form Release Citrus is recommended for use on various types of forms such as wood, steel, fiberglass, or aluminum.

SPECIFICATION CONFORMANCE

This product meets the maximum VOC content limit for form release compounds as required by the U.S. EPA Architectural Coatings Rule and the rigid specifications set forth by the Ozone Transport Commission (OTC).

INSTALLATION INSTRUCTIONS

Treat and season forms prior to each use with brush, roller, or hand sprayer. Do not exceed 30 PSI with fan type sprayer. Avoid excess run-off or ponding by only applying a thin coat. Coverage rate is approximately 600-1000 ft²/gal (14.7–24.5 m²/L) for plywood/lumber forms and 1000-2000 ft²/gal (24.5–49.1 m²/L) for aluminum/steel forms.

LIMITATIONS

- For exterior use only
- Not to be used as tilt-up bond breaker
- Adequate ventilation necessary during application

STORAGE
